WEBSITE COOKIE INFORMATION NOTICE

As **NETRD BİLGİ TEKNOLOJİLERİ VE TELEKOMÜNİKASYON A.Ş.** ("Company"), we would like to inform that we use cookies through our Website, and we take utmost care to process the personal data of our Website visitors pursuant to the Personal Data Protection Law No.6698 and applicable legislation ("**PDP Legislation**").

The purpose of this Cookie Information Notice is to inform you about the types and purposes of use of the cookies obtained during the website users/visitors' ("**Data Subject**") visit to our Website at https://netrd.orioninc.com.tr ("**Website**").

What is a Cookie?

Cookies are small text files, mainly consisting of letters or numbers, that are stored on your computer or mobile device ("device") when you visit a website, allowing the device to be identified.

What are the Collection Methods of Cookies and the Legal Grounds for Processing?

When you visit our Website, your personal data will be processed through strictly necessary cookies, persistent cookies, and analytic cookies so that you can benefit from the Website based on the legal reason for exercising the rights.

What Types of Cookies Are Used?

Our Website uses both first-party cookies (placed by the Website you visit) and third-party cookies (placed by servers other than the Website you visit). Below you can find the different types of cookies we use on our Website:

Strictly Necessary Cookies: These cookies are strictly necessary for the Website to function properly and for you to benefit from its features and services. For instance, authentication cookies, which are activated when you log in to our Website, ensure that your active session continues when you switch from one page to another on our Website. Disabling these cookies may cause services and features to be unavailable.

Persistent Cookies: These are cookies that are used to increase the functionality of the Website and to provide faster and better service to our visitors, and are valid until you delete them through browsers or until the expiration date. These types of cookies are used to remember your choices and personalize your use of the Website. This includes cookies that save your user password and keep your Website session open, saving you the hassle of entering a password multiple times each time you visit, and cookies that remember and recognize you on subsequent visits to the Website.

Functionality and Analytic Cookies: These are cookies used to determine how you use the Website, including tracking from where you connected to the Website, what content you viewed on the Website and the duration of your visit.

Which Cookies are Used for which Purposes?

As a company, we use cookies for various purposes on our Website, and we process your personal data through these cookies pursuant to the PDP Legislation limited to the following purposes. These purposes are mainly:

- Performing the essential functions necessary for the operation of the Website, For instance, ensuring that the logged-in members do not need to enter passwords again while visiting different pages on the Website and that your active session continues when you switch from one page to another on our Website. Disabling these cookies may cause services and features to be unavailable.
- Analyzing the Website and improving the Website's performance: For example, integration of different servers of the Website, determining the number of visitors to the Website, adjusting performance accordingly, or making it easier for users to find what they are looking.

To Whom and For What Purpose Can Cookies Be Transferred?

As a company, our suppliers from whom we receive technical support in the activities that constitute the subject of the Cookies Information Notice access your cookies data. Moreover, these data are shared with legally authorized public institutions in judicial proceedings.

The Company matches information collected online and offline through different methods or information collected from you on the Website at different times and uses this information together with information from other sources, such as third parties.

How Can You Control Cookie Usage?

The use of cookies is not mandatory to use our site; you can customize your preferences regarding cookies by changing your browser settings.

If you set your browser to block all cookies, you can continue to use our Website; however, you may not be able to access or have limited access to all functions of the Website, and the quality of your user experience may decrease.

What are Your Rights as the Data Subject?

We would like to inform you that you have the following rights regarding your personal data pursuant to Article 11 of PDPL:

- to learn whether your personal data are processed or not,
- if processed, to request information regarding this procedure,
- to learn the purpose of your data processing and whether such data are used for intended purposes,
- to learn the third parties in the country or abroad to whom personal data have been transferred,
- if personal data is processed incompletely or inaccurately, to request correction of the same and request for such correction to be informed to the third parties to whom the personal data is transferred,
- although processed in compliance with PDPL and provisions of other applicable laws, if
 reasons for processing are no longer available, to request erasure or destruction of their
 personal data and to request for such transaction to be informed to the third parties to
 whom their personal data is transferred,
- to object to the occurrence of any result that is to their detriment by means of the analysis of processed personal data exclusively through automated systems, and
- to request compensation for the damage arising from the unlawful processing of their personal data.

or by other methods to be determined by the Board in the future.
